TENDER NOTICE

Public Prosecution Department, Lahore intends to procure below mentioned items and invites tenders from the interested Firm/Company/Supplier/Distributor/ individual / AOP registered with Sales Tax, Income Tax, Professional Tax & Punjab Revenue Authority for Financial Year 2025-26 & 2026-27. Single Stage - Two Envelope Bidding Procedure shall be followed and bidder will provide separately financial bid and technical bid for **each lot** of procurement. The bidder shall provide bids for each item mentioned in each lot. A bidder may participate in one or more or all lots; however, the bidder must quote for all items specified in the respective lot. Failure to submit a bid for any item within a lot shall render the bid non-responsive for that lot. Financial evaluation shall be conducted on a lot-wise basis, with the lowest evaluated cost determining the successful bidder for each lot. The lots of procurement are given below: -

The bids along with scanned copy of the Bid Security @ **03%** of the estimated value given in Standard Bidding Documents, Tender Forms, Affidavits, etc., must be submitted / uploaded through EPADS and original instrument shall be delivered in in the office of Section Officer (General), Public Prosecution Department before **09:30 AM** on **[14.05.2026]** in sealed envelope, failing which will cause rejection of bid. The tender will be opened on the same day at **10:00 AM** in the presence of owner of the firm / bidders or authorized representatives of the firms. The Technical Evaluation Committee shall conduct an initial technical evaluation of the bids in accordance with the criteria outlined in the tender documents. Following the evaluation and approval of the technical proposals, the Procuring Agency will publicly open the financial proposals of only those bidders whose technical proposals have been declared responsive. The date, time, and venue for the opening of financial proposals will be communicated to the technically qualified bidders in advance. The Procuring Agency reserves the right to reject all bids in accordance with the Punjab Procurement Rules, 2014.
